RECOMMENDATION:

The Watershed Advisory Committee approve the Communications Plan for the Watershed-Based Resources Strategy and the Conservation Lands Strategy.

DISCUSSION:

South Nation Conservation is developing a Watershed-Based Resource Management Strategy and a Conservation Lands Strategy, as part of the requirement of Ontario Regulation 686/21.

These strategies will establish guiding principles and objectives to guide the design and delivery of program and services, including supporting information, reviews, and future updates (WAC-007/24, WAC-008/24, WAC-015/24, WAC-16/24).

Consultation is an important part of strategy development and must be completed before the strategies are finalized by December 31, 2024.

Stakeholder feedback will be shared with the Watershed Advisory Committee and incorporated into the strategies. Public feedback will be solicited once the draft strategies are available and will be guided through an online information session and public feedback forms. Feedback will be advertised through newspaper and social media advertisements.

The attached Communications Plan includes target dates, timelines, and deliverables for public consultation on Conservation Authority Strategies.

- Stakeholder feedback will be coordinated through the Watershed Advisory Committee.
- Public consultation will encourage feedback from residents and community groups on the draft strategies.

Subject: Update: Watershed Based Resource Management Strategy – Risks and

Opportunities

RECOMMENDATION:

That the Watershed Advisory Committee receive and file the update on the Watershed Based Resource Management Strategy risks and opportunities.

BACKGROUND:

Section 21.1 of the *Conservation Authorities Act* (the "Act") and Ontario Regulation 686/21 under this Act requires that each Conservation Authority develop a Watershed Based Resource Management Strategy by December 31, 2024. A presentation was made to the Committee in April 2024, explaining the requirements and process, and in June, summarizing the existing knowledge SNC relies on for program and service delivery.

DISCUSSION:

SNC staff participated in a series of brainstorming sessions to identify risks to effective program and service delivery and opportunities to address those risks, for each program area. The brainstorming sessions included general discussion and an identification of strengths, weaknesses, opportunities, and threats for each program area.

The attached table summarizes the outcomes of the discussions, which have been grouped into the following key themes: Financial, Strategic, Compliance, Operational, Reputational, and Climate Change.

FINANCIAL IMPLICATIONS/ADHERENCE TO SNC POLICY:

<u>Compliance with Budget</u>: The preparation of the Strategy is included in the 2024 Budget under Approvals: Projects: Watershed Studies, pages 90-91.

<u>SNC Policy Adherence</u>: Ontario Regulation 686/21 sets out the Mandatory Programs and Services which must be delivered by all conservation authorities in Ontario. WATERSHED BASED RESOURCE MANAGEMENT STRATEGY – RISKS AND OPPORTUNITIES [DRAFT]

FINANCIAL

Risks

Increasing capital costs put timely inspection, maintenance, and repair of infrastructure at risk. Infrastructure failure would create a risk to public health and safety and may cause flooding and property damage.

Continued provincial freeze on application fees for planning and regulations.

Opportunities

Address budgetary constraints by exploring the option of implementing a capital levy to cover costs of infrastructure maintenance and replacement.

Ensure that, when possible, development pays for development through appropriate user fees for planning and regulations.

Investigate opportunities for Category 3 agreements with municipalities relating to improvements to watershed monitoring.

STRATEGIC

Risks

Staff turnover and lack of qualified staff create shortfalls and risk of losing institutional knowledge.

Natural hazards and watershed management programs rely on outside sources of funding, including grants from the federal and provincial governments, which include additional requirements and strict timelines. This adds to uncertainty and hinders long-term work planning.

Opportunities

Engage in succession planning and increase opportunities for cross-training between departments to enhance operational resiliency.
Use data to identify strategic priorities for stewardship activities.

Leverage the expertise on the Watershed Advisory Committee to guide strategic program direction.

Continue to engage municipal staff with Municipal Information Day and maintain good relationships on an ongoing basis.

COMPLIANCE Risks

Some of SNC's mapping of natural hazards is outdated or incomplete. For example, older floodplain studies did not include erosion hazards. SNC has limited or incomplete mapping for wetlands, karst features, and potential retrogressive landslide risk areas.

Opportunities

Continue to use the 10-year workplan to prioritize new floodplain and erosion control mapping projects as funding becomes available.



OPERATIONAL

Risks

Sediment accumulation & erosion along shorelines due to cumulative impacts of loss of riparian vegetation.

Monitoring data collection relies on external agencies, telecommunications networks, etc.

Without standardization, application submissions are inconsistent, presenting challenges for technical reviews.

Opportunities

Advertise and prioritize clean water program and other opportunities for restoration of shorelines and riparian areas.

Acquire, develop, and use new software and hardware tools to improve data collection and analysis.

Continue to develop technical guidelines and detailed submission requirements for permit applications.

REPUTATIONAL

Risks

Public understanding of the interconnectedness of development and flooding and erosion is limited.

Opportunities

Design and implement public education programs to address: water safety, flooding, drought, landslides, shoreline restoration, cumulative impacts of development on watershed conditions.

Improve the public geoportal and consider making more SNC data available to the public.

CLIMATE CHANGE

Risks

Climate change effects flooding, erosion, and landslides due to higher temperatures, more rain, increased severe weather events, changes to ice cover, and water temperature.

Opportunities

Use new technologies to enhance modelling and include more data in modelling.

Analyse large flood/drought events.

Develop a Climate Chage Strategy for SNC.

RECOMMENDATION:

DISCUSSION:

South Nation Conservation (SNC) is preparing a Watershed-Based Resource Management Strategy (the "Strategy") in accordance with Ontario Regulation 686/21 Mandatory Programs and Services under the *Conservation Authorities Act*.

The Strategy includes SNC's guiding principals and objectives, and a review of a programs and services to identify issues and risks that limit effective program delivery.

In support of the Strategy, the Committee completed a survey and environmental priorities exercise at the June meeting. Building on this work, Staff will guide the Watershed Advisory Committee through a SWOT (strengths, weaknesses, opportunities, and threats) analysis of Watershed Programs and Services during the meeting. Program analysis will include:

- landowner stewardship (tree planting and clean water program)
- outreach and education (youth and school programs)
- habitat restoration
- conservation lands

This analysis will help to identify mitigating actions to reduce identified issues and risks and provide input for future direction of these programs and services.
