

- Asset Management Plan to be fully implemented in 2025.
- Inflation (Sept to Sept 1.6%).



Budget Schedule – General Notes

Salaries and Employee Benefits

- Example: a \$85,000 salary will cost approximately \$109,000 including payroll premiums, group benefits, and pension plan contributions
- Effective July estimate 2.5% COLA, minimal budget impact
- Increase per personnel policy average of upper tier municipal partners
- 47.4 FTE's 2025 budget vs
 46.1 FTE's 2024 forecast



Travel and Training

- Travel: includes transportation costs for site visits, customer visits, and external meetings
- Training: includes mandatory training (First Aid/Health and Safety etc.); technical (maintain expert levels); and conferences (partner and peer networking)



- New agreement with Township of Alfred and Plantagenet for forestry services.



- 13,000 acres of land has been managed for over 60 years.
- Planned management activities in
 5-Year Forest Operating Plan.
- Certified Forest Management since 2005.
- Tree management due to extreme weather events and invasive species.
- Wetland and shoreline restoration projects supported by external revenue.





Approvals: Municipal Plan Input & Review and Regulatory Services

- Protect people and property from natural hazards under Section 28.1 of the CA Act, and Section 5.1 of the PPS;
- Advise and collaborate with 16 partner municipalities for Plan Input & Review
- In 2024, reviewed and provided comments on 360 planning and development files; 150 property inquiries; and 350 regulation permit applications
- High quality internal technical review and engineering services provided by SNC



Site Visit Township of South Dundas





- Approvals Team currently assisting with updating the Source Protection Plan through Section 34 and Section 36 Amendments
- Administer the Risk Management Office on behalf of 13 municipalities
- Prepare risk management plans and issue Section 59 notices (15 completed in 2024)
- Budget for 2025 includes staff time for the Risk Management Office, policy updates, Education and Outreach, monitoring programs, and special projects.


- Chief Building Official issues permits on behalf of 16 local municipalities under Part 8 of the Building Code
- Inspect new construction, alteration, and maintenance and compliance
- Provide training for local contractors, municipalities and the Eastern Ontario Health Unit
- Similar to 2024, expecting 450+ new permits, 200+ severance reviews; and 280 file searches and compliance reviews.
